# Business Retention Lending Program

YSEDC'S Business Expansion and Retention (BEAR) program helps retain existing jobs and business tax revenues, create new jobs and increase the existing business base, foster growth and development of local firms and enhance the community's reputation as a great place to do business. This program is designed to keep our businesses from relocating, to help them survive economic difficulties, assist with expansion projects and increase competitiveness in the marketplace. The BEAR program has been developed to fully engage the business resources in the community to grow local businesses by identifying barriers and strengthening relations

The Lending program for businesses is a structured credit-improvement regimen to prepare business owners for more conventional financing products. The program creates coaching capacity to help prospective borrowers navigate the wide range of private, government and community based lending products. This program assists with assessment of current and future financing needs; identifying relevant financing products; determining best use for each type of financing; and assisting borrowers through the loan process and provide post-loan assistance.

## **BUSINESS ATTRACTION**



#### **OUR ANNUAL ACCOMPLISHMENTS IN 2024**



**Business Attraction -** YSEDC responded to 29 private investment inquiries about the Yuba and Sutter region that had the potential to bring thousands of new jobs to the area. There was two businesses did receive proposals for siting which have the potential to create 25 jobs. Unfortunately, until regional infrastructure is built up, the region is unable to site most of these businesses.

Workforce Development & Business Technical **Assistance** - YSEDC and its Yuba-Sutter Business Consortium partners provided over 1,686 hours of technical assistance to 3,224 businesses and provided 3,956 business services to employers. These include referrals, hiring and tax incentives, incumbent working training, HR consultation, local job openings, job fairs and on-site recruitment, and created 457 jobs and retained 120. In addition, 12 business training events were provided to 81 businesses. YSEDC provided 21 scholarships to local nonprofit organizations, 5 QuickBooks Online subscription scholarships,. Additional outreach efforts and technical assistance included leads and application assistance for Federal, State and Private Foundation grants and loans.

Strategic Planning - Comprehensive Economic Development Strategy (CEDS) annual update and evaluation was completed. There were 21 economic development initiatives totaling \$217,660,360 in public and private sector investment and 298 jobs created or retained from the CEDS strategy implementation during this period. Marysville Facade Improvement Grant
Program - Partnering with the City of Marysville,
YSEDC is managing this program to help
improve the historic downtown corridor. To date,
30 businesses have been approved for funding
for their projects

YSEDC Jurisdiction Grant Technical Assistance: YSEDC provided grant writing and application assistance to Sutter and Yuba Counties, the cities of Live Oak, Marysville, Wheatland, and Yuba City. These grants were for a variety of public works projects ranging from workforce development to infrastructure improvement. Three grants were awarded totaling \$761,000 and two \$20 million grants are pending.
